




2012 CERA Activity



Referrals to CERA continued to be steady in 2012, and the year shall certainly be recognized as one of the better years in terms of referrals.




Municipalities served by CERA are represented well in terms of referrals. Considering the population in each municipality, the breakdown of the number of cases received from each municipality is proportionately comparable.




*The 'Other' category includes two neighbourhood disputes as well.

Cases from referring partners demonstrated significant range in 2012; indicative of CERA's proficiency in proving its capability in dealing with offences that are diverse in nature.

CERA continued to work closely with School District 43 to support the culture of restorative justice in schools. Several schools expressed interest and commitment to incorporating peer mediation training in their schools and/or choosing a restorative justice process in addressing conflict. Those schools included Porter Elementary, Banting Middle, Como Lake Middle, Centennial Secondary, Hillcrest Middle, Maillard Middle, Harbor View Elementary, Coquitlam River Elementary, Kilmer Elementary, and Meadowview Elementary.
